If I am given the applied privileges, I understand that I am free to resign at any time, with or without cause and without prior notice, and the speedway management reserves the same right to terminate my privileges At any time, with or without just cause and without prior notice, except as may be required by law.

This application does not constitute an agreement or contract for privileges for any specified period or definite duration. I understand that no supervisor or representative of the speedway is authorized to make any assurances to the contrary and that no implied oral or written agreements contrary to the foregoing express language are valid unless they are in writing and signed by the speedway's owners. Susquehanna Speedway Inc. and its management is not responsible for any damage that may occur to my personal property while on the property of SUSQUEHANNA SPEEDWAY INC. I hold them harmless from any and all claims that may occur.
